Background

Leitrim County Council in partnership with Waterways Ireland are proposing the development of a Blueway Trail from Acres Lakes, Drumshanbo to Battlebridge comprising the construction of a timber/steel boardwalk and bound path around the foreshore of Acres Lake, linking into proposed new unbound paths and existing established paths along the Lough Allen Canal. It is anticipated that a planning application will be submitted by Leitrim County Council in August/September 2015 and a requirement for this application is agreement/support in principle by any land owner who may be affected by the proposed development. Should the application be successful Leitrim County Council and/or Waterways Ireland's Property & Legal Section will enter into negotiations with each of the respective landowners to procure the necessary parcels of land required to facilitate the development.

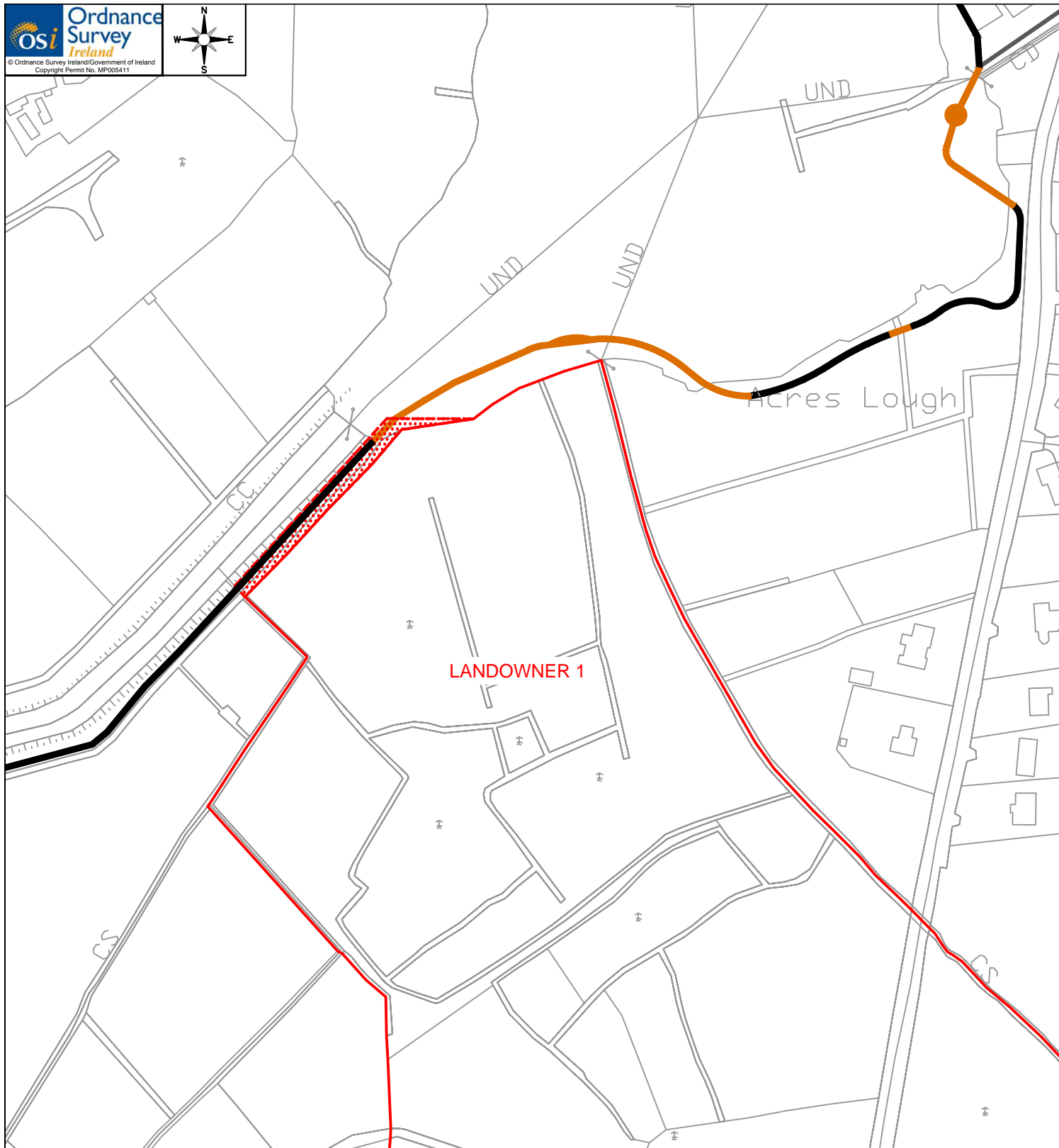
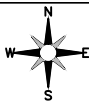
